(\$125.00) to one hundred fifty (\$150.00) dollars.

WHEREAS, The County Commissioners in the best interest of Crawford County, wish to amend, modify or change the fees for Rezoning, Special Exceptions, Conditional Land Use, Variances, Special Events, Moving and Subdivision/Platting Application in the following manner.

That the noted fees for Conditional Land Use, Rezoning only, Special Exceptions, Variances, and Appeal applications will be increased from two hundred (\$200.00) dollars to two hundred twenty five (\$225.00) dollars. These fees will cover expenses incurred for application packet, filing fees, postage and notification of adjacent landowners only.

That the noted fees for a Moving Permit will be increased from ten (\$10.00) dollars to thirty five (\$35.00) dollars.

That the noted fees for Subdivisions/Platting, Lots Splits, and Short Plats will be increased from two hundred twenty five (\$225.00) dollars to two hundred fifty (\$250.00) dollars.

That the noted fees for Special Events will be increased from fifty (\$50.00) dollars to seventy five (\$75.00) dollars
